Who We Are: Boys & Girls Clubs is a private non-profit 501 c(3) organization that has served the youth of Fresno County for sixty years, operating continuously since its founding in 1949.

Affiliation: The Boys & Girls Clubs of Fresno County is a member of the Boys & Girls Clubs of America, serving some 4.5 million children in more than 4,300 communities across America and on U.S. military bases around the world.

Mission: To enable all young people, especially those who need us most, to reach their full potential as productive, caring, responsible citizens.

Services: We operate seventeen Clubs for youth ages 6-18 in Fresno County: Fresno, Clovis, Pinedale, Del Rey, Parlier, Orange Cove, Huron, Firebaugh, Mendota, Sanger, and Oakhurst in Madera County. In addition, we have a Club in the Juvenile Justice Campus (Juvenile Hall) of Fresno County. In 2009, we served more than 12,000 youth. Hours: Clubs are open five days a week after school until 8:00 PM, when kids have free time and need a safe and positive place to learn and grow.

Programs: We provide diversified programs that meet the interests and needs of youth:

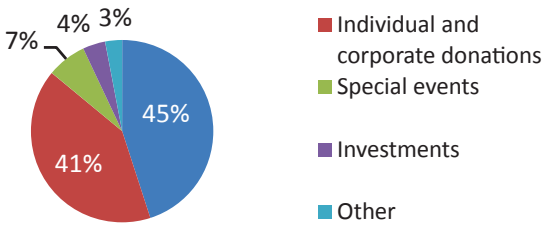
- Character and Leadership Development

Staff: Every location has full-time, trained youth development professionals, providing positive role models and mentors. In addition, volunteers provide key supplementary support.

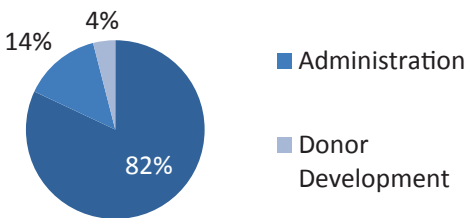
